## NEWS

**HOME MISSION GIVING:** The Association total for giving to Baptist Home Mission in 2016 was £329,746, up from £327,122 in 2015 but below our target of £332,659. Many thanks for your continued prayer and generous giving that makes ministry and mission possible. Regrettably the overall national total fell in 2016. The failure to achieve the national appeal will be reflected in the funding available to the Association for operational and grant funds and it is anticipated that the 2018 budget will show a reduction in funds to associations. So, please pray for those charged with addressing the Union's finances and also pray for the Association trustees that they will be able to put the funds available to best use.

**FACTS & FIGURES:** Your church should have received recently the Annual Return from the Baptist Union of Great Britain. Please make sure that this information is processed and returned, whether online or post. It is such a blessing for the Baptist Union to have the right information and the right contacts.

**FOR TRUSTEES:** We had intended to run a training session for Trustees on March 11<sup>th</sup> but after consultation with the session leader, we have agreed to postpone this until later in the year.

**ASSOCIATION COUNCIL: Digest January 2017** The Association Council met on January at Bradwell Chapel, Milton Keynes. It was recorded that the Association had nominated the Revd David Gregory (Croxley Green BC) as Vice President of the Baptist Union 2017-18. Reports were received from Geoff Colmer and Colin Pye and some places on Association-connected committees and organisations were noted. There had been two nomination for Council – Andrew Openshaw (Herts) and David Warrington (Northants).

It was noted with regret that Danesholme LEP, Corby had closed at Christmas and that Earls Barton (Northants) would hold its last service in April. Also noted that Keysoe Row & Thurleigh BC (Beds) was becoming a single congregation LEP with the parish church, then to be known as Thurleigh United Church.

Consideration was given to the Council strategy, in particular the section relating to “developing Christ centred, committed and equipped disciples for different forms of ministry”. The strategy is assessed on a regular basis to make sure that any elements achieved are deleted, continuing objectives affirmed and new ones given expression.

Karen Hopkins, the Association Treasurer, reported that the draft out-turn from 2016 had been a lower deficit than budgeted (ca £50k and not £60k). This figure would probably be adjusted slightly after revaluations and depreciations. Home Mission giving had risen slightly from £327.122 to £329.746, a cause for satisfaction. Some £122.788 had been given in Home Mission grants. Response to the national appeal had been muted and a challenging budget for 2018 was anticipated. There had been queries arising from the Financial Services Act about whether the Association was able to make loans without specific authorisation. Advice would be sought. This did not affect current loans outstanding.

Due to the static low returns on deposits, trustees had requested a small group to investigate moving some reserves into an investment portfolio and interviews had been held with several appropriate firms. It was decided to appoint 7IM as the Association investment broker. Whilst this would not bring overnight financial success, it was intended to bring medium term a better return on reserves, which was necessary to bridge the budget deficit. Council was aware that the risk factor was raised in this sort of investment but on balance deemed the increased risk acceptable.

The difficulties with the Baptist Pensions Scheme were rehearsed with expressions of regret and a certain amount of helplessness. Concern was expressed for churches that are finding it a burden to meet the historic debt repayments. The trustees were willing to consider proposals being brought forward nationally to offset some of the historic debt but were also aware of the need to maintain the service and resources of the Association in line with their charity responsibilities. It is hoped that a meeting led by people involved in the national discussions will be held in the Association in mid-year where representatives of churches will be able to gather and discuss the pension situation.
